# 4. President's report

- 4.1. Equity rural scholarships: 18 Equity rural scholarships awarded in 2022. Significant changes made to scholarship eligibility and award criteria to align it better with its aims. Since 2017, 107 scholarships have been awarded totalling over \$130,000. The President thanked the scholarship sub-committee for their contribution towards managing these scholarships.
- 4.2. WIL in Practice Online Journal: Two editions published in 2022 totalling 10 publications.
  Members are encouraged to submit to the journal or become a reviewer. Expressions of interest currently open for the editorial board. WIL in Practice has a focus on providing opportunities for people who may not be able to publish in other types of publications.
- 4.3. Placement fee project: At the end of 2022 NAFEA commissioned a project to explore the cost of placements for universities in the areas of education and health. Approval has now been finalised and the project will receive \$10,000 in funding and the project is also receiving in-kind contributions from members of the project team. The project team consists of a number of NAFEA members representing a diverse range of interstate institutions and is co-lead by Elise Bailey (Griffith) and Dr Anne McLeod (Charles Sturt). The purpose of the project is to explore the enablers, barriers and impacts of higher education providers paying for WIL activities.
- 4.4. NAFEA Conference 2023: Will be held 18 20 October in Cairns. Theme is *The WIL to thrive: a brave new world.* The theme is intended to be a positive message after the last 3 pandemic-affected years. Early bird registrations close on 31 August. Members are encouraged to present at the conference.
- 4.5. The President encouraged members to check their institutional membership status and encourage their institution to renew or retain their membership.



# 5. Treasurer's report

5.1 Presentation of 2021-2022 Annual Statement: Statements were accepted by members. All finances were prepared and audited by a qualified accountant.

#### 5.2 Summary:

#### **NAFEA's income** is split between 2 sources:

Conference registrations (11%)

2021 Online Conference = \$2880

2022 Online Conference = \$5839

Memberships (89%)

20 Institutional Members. Membership has grown over the last 3 years.

2021 membership fees = \$24,180

2022 membership fees = \$27,060

#### NAFEA's expenditure:

Two main areas of expenditure are conferences and scholarships. Other notable areas of expenditure are website hosting and management (including the online journal), project grants and operational costs including accountancy.

5% of income is saved each year as a contingency and the rest goes back to members. COVID impacted income for two years but NAFEA's income is starting to recover and this will be reflected in an increase in grants awarded moving forward.

## 6. General business

#### 6.1. Insurance

Insurance was considered. The association continues to hold insurance for in-person conference events. No other insurance is required by the association due to our lack of building structure.
